

SEA WOLF ADVENTURES, INC TERMS AND CONDITIONS

TRIP COST INCLUDES: The following costs include shipboard accommodations, ship excursions, crew, all meals, and guides, unless otherwise indicated in the itinerary. We reserve the right to make any changes in the itinerary or crew.

TRIP COST DOES NOT INCLUDE: The cost of air flights, unless otherwise indicated in the itinerary, taxes, passports, visas, immunizations, insurance of any kind, laundry, excess baggage, items of a personal nature, medical costs, costs of hospitalization, additional expenses arising from the delay or extension of a trip due to weather, political disputes, illness, failure of transportation, or other causes beyond our control. Gratuities are not included. A possible fuel surcharge of 5% if prices rise again.

RESERVATIONS: Reservations are limited and on a first-come basis. To reserve space on any trip, please contact Sea Wolf Adventures for trip availability at 907/957-1438 or email: <http://seawolfadventures.net/contact/>

PAYMENTS: All payments should be made by personal check, money order, certified or cashier's check, in US Dollars. Or direct deposit in US Dollars.

At the time of reservation: 50% deposit is due which includes a non-refundable deposit of US \$500 per person per trip or \$6,000 per Whole Boat Charter. This is required to guarantee your reservation.

Balance is Due 90 days prior to departure.

CANCELLATIONS: If you find it necessary to cancel your trip, please notify us as soon as possible. You can telephone, but we will also need a written notice.

Cancellation Terms:

More than 150 days prior to departure: Refund of deposit minus booking deposit. 120 to 90 days prior to departure: Forfeiture of total deposit.

89 to zero days prior to departure: Forfeiture of trip cost. We will make every effort to fill a canceled booking. If we are able to refill your cancelled stateroom we will refund your payments less the booking deposit.

INSURANCE: WE STRONGLY RECOMMEND that you obtain Travelers and Trip Cancellation Insurance to protect yourself. AAA, AARP, Travel Guard are known Insurance carriers.

TRANSFER: With 90 days advance notice, there is no charge for transferring from one trip to another, subject to availability.

CANCELLED TRIPS: We reserve the right to cancel any trip prior to the scheduled departure due to under subscription or logistical problems (vessel breakdown, strikes, etc.). You may transfer to another trip or we will refund all payments made to Sea Wolf Adventures, Inc. in full. In no event, however, shall our liability exceed the obligation to refund the amount you paid to us. Trip cancellation due to under subscription would occur at a minimum of 45 days prior to departure.

ACCOMMODATIONS: Vessel accommodations are semiprivate. Choice of cabins is on a first-come, first-served basis. All cabins accommodate couples or two companion travelers. If you prefer a cabin to yourself, there will be a rate supplement of 50% of the single fare cost.

WITHDRAWAL: Sea Wolf Adventures, Inc. reserves the right to require any participant to withdraw from a trip at any time if the captain deems his or her acts or conduct detrimental or incompatible with the interest, harmony, comfort, or welfare of the trip. In such cases, no refund will be given.

MEDICAL: Although Sea Wolf Adventures trips are not physically rigorous; you need to be in general good health to participate in all activities. It is the passengers' responsibility to judge the appropriateness of their physical capabilities to these travel activities. Anyone with medical problems or restrictions must make them known to us well in advance of the trip and should bring a personal supply of any special medications. The captain has the right to ask any member of the group not to participate in an activity if he/she considers it medically necessary; no refund will be made under such circumstances. Sea Wolf Adventures, Inc. takes no responsibility for special arrangements required by passengers physically unable to complete a trip and assume no liability regarding provision of medical care.

SMOKING: Participants may not smoke below decks or within any enclosed area of the vessel. Smoking is allowed on the second deck leeward rail when the wind is blowing sternward only.

CHILDREN ON TRIPS: Our trips are adult oriented, but some may be suitable for children, depending on the child's age and experience. Private boat charters are for 12 persons and may include children. Please contact us.
